Unfinished Business:

Ronald Miller updated the George Washington Chapter Patriot Cemetery Initiative of constructing and installing Revolutionary Patriot identification signs for selected Washington County cemeteries (58 locations).

14 signs have been installed at cemeteries. 12 signs to be installed through September (11 have been funded by donations from the DAR). An application has been submitted to the Washington County Community Foundation for a grant to complete the project county wide (32 remaining locations). Approval of the grant will enable a radio (WJPA) spot to promote our chapter activities associated with the initiative and we will develop printed brochures. Also, a joint venture with the David Bradford House Association for the summer of 2022 includes a Revolutionary War Patriot/Whiskey Rebellion History Scavenger Hunt as part of the Whiskey Rebellion Festival. This competitive organized event will allow participants to travel to the different historical cemeteries to find answers to clues from our signs with the computer interface. Signs cost \$55 each if we do assembly and installation. If we get the grant and have a restrictive timeframe the cost is approximately \$230 each for sign, assembly and installation.

FP Thomas Showler reported on PASSAR Pa license plates. Currently, cost \$28 payable to PENNDOT and \$25 payable to PASSAR. Contact him for more information. Also, find it on the Member Section on the website.

Secretary Russell Mills reports that all new member packets will include the tag.

Secretary Russell Mills reported that the dues collection for 2022 will begin soon. He has updated the membership lists and is in the process of aligning our membership with the PASSAR Database. Chapters have received these updated membership lists (XL spreadsheet) so please assist/remind your members to pay their dues. The dues notice will include a place to make a voluntary contribution to the 2024 National Congress. Also, be reminded to update your contact information. Out of 1800 members 500 do not have email addresses. Please update your email address with the Secretary. Membership information is protected.

First Vice President Michael Siebert clarified that the funding for the 2024 National Congress mailing did not come from the General Fund. That expenditure came from a separate account funded by donations for the 2024 National Congress. Treasurer Don Mengle added that the Zoom equipment was paid from an account that will be reimbursed by the Zoom participant registration fees. The equipment cost \$1,969, however, with depreciation over four years, will result in no cost to PASSAR.

Treasurer Don Mengle also reported that he is in the process of obtaining a Pennsylvania Sales Tax Exemption. There is not a guarantee that it will be granted, though. If approved, we should have it within 60 days. Chapters should be able to fall under this sales tax exemption as well. Included on pages 108-111 are the SAR Tax Letters which are provided for your information.

President Lick thanked the Great Glades Chapter for their support for the meeting. He closed the meeting and led the Recessional. The colors were retired and Robert Grumbling, Jr. gave the Benediction.

Dear President Lick and Secretary Mills:

The first portion of this report covers the Reserve. The last paragraph provides information on the Permanent Fund PASSAR.

Reserve

This report is submitted for the period through September 30, 2021. This report is being filed pursuant to Bylaw No. 8, Section 8.05-a. **Quarterly Reports.** The Meeting is being hosted by the Continental Congress Chapter.

As of September 30, 2021 the Reserve total was \$165,066.33. Of this amount \$2,528.67 was held in the Wells Fargo brokerage account in cash. In addition, \$1,059.10 was held in the Citizens Bank checking account in cash. The total of cash in both accounts in the amount of \$3,587.77 was available for transfer to the PASSAR General Operating Account, if needed. The remaining funds, the non-cash items, in the Wells Fargo brokerage account are invested in various equities, bonds and mutual funds.

In addition to the above investments, PASSAR maintained, until the end of December, cash in a restricted Citizen's Bank account that was dedicated to the support of the Museum of the American Revolution pursuant to PASSAR's pledge to donate a total of \$50,000 in increments of \$10,000 per year over five years. To date five installments of \$10,000 each have been made on PASSAR's five year pledge. The first \$10,000 was paid by a Citizens Bank counter-check dated September 2, 2016. The second \$10,000 installment was paid by PASSAR's Citizens Bank check dated September 1, 2017. The third \$10,000 installment was paid by PASSAR's Citizens Bank check dated September 12, 2018. The fourth \$10,000 installment was paid by PASSAR's Citizen Bank check dated November 4, 2019. The fifth and last \$10,000 installment was paid by Citizens Bank's Official Check dated December 23, 2020.

As previously reported on August 4, 2017 three separate \$50,000 checks were issued to the then newly-formed Permanent Fund PASSAR which is managed by PNC. This cash was made available by the liquidation of various equities and mutual funds from PASSAR accounts. These transfers of money were required to comply with the terms of three bequests of the Joseph Ramsey and Elizabeth Ramsey wills. The Permanent Fund PASSAR is managed and reported on by Donald E. Mengle, the PASSAR Treasurer, independent of the Reserve.



Dear Compatriots:

For those chapters planning to submit an activities scoresheet for 2021 – and I hope to see increased participation this year – please be aware of some changes.

Because NSSAR shaved 2 weeks off the previous deadline, I need to have your report no later than **February 15, 2022,** and preferably sooner if you can manage it.

Secondly, NSSAR has revised the scoresheet by reducing the number of tabs from 16 to 12 through consolidations and other modifications. Consequently, in order to compete for an award, a chapter must have activity in 9 of 12 category tabs for Americanism and 5 of 7 for the PG Streamer. However, I encourage each chapter to complete a scoresheet regardless of the number of categories in which a chapter engages since the scoresheet does act as a guide and record for chapter activities. Chapter size categories for competition are now designated as 1-40, 41-90, 91-150, and 151+ rather than the previous three categories.

In March I distributed a link for the 2021 scoresheet to all chapters. The scoresheet can also be found on the NSSAR website at the Americanism Committee page or I can e-mail the scoresheet. It would be helpful for the chapter to enter its data throughout the year as activities occur.

Lastly, if your chapter opts not to submit a scoresheet for whatever reason, it still would be helpful if you would inform me of 2021 chapter awards (names and dates, please) and other activities that might increase the overall PASSAR score for the society-to-society competition. Still, I hope to see many more chapters submit a scoresheet for 2021.

The Public Service and Heroism(PS@H) Commendation booklet for the award year 2020/2021 lists the total number of PS@H awards given by each State Society, by each Chapter of the State Society, and the total numbers for each category.

Here is some information from the last annual PS@H Commendation booklet.

During the award year 2020/2021 Pennsylvania gave 34 Public Service and Heroism awards Broken down into the five awards categories the results are 11 EMT awards, 17 Law Enforcement awards, four Life Saving awards, two fire safety awards and zero awards for Heroism.

Recognition is given to the states that have presented awards in all five categories. Since Pennsylvania did not present any Heroism awards Pennsylvania is not in this category but this coming year it can be and it will be. We will be monitoring that. The five states that gave awards in all five categories were

Arizona, Florida Missouri Texas and Virginia.

Pennsylvania was recognized for presenting awards in four of the five categories along with California Georgia, Indiana and North Carolina.

For purposes of information the states reporting the highest number of awards presented were Texas --46, Florida -45, Virginia-44. North Carolina matched Pennsylvania and presented 34 awards.

When I read about or learn about in some way an event involving a person or persons who engaged in some activity that would seem to qualify for an award presentation. I will contact the chapter that services the area where the event occurred.

The process of identifying persons who qualify for a Public Service and Heroism award and helping them to obtain recognition for their actions can be a very interesting and rewarding experience for them as well as for the compatriot and his chapter. Although many chapters have a person designated to coordinate possible Public Service and Heroism award candidates it is a program all chapter members can be involved in. Listening closely to the news and skimming through the newspapers you receive as well as observing your neighborhood can bring to your attention possible recipients for Public Service and Heroism awards.

Wreaths Across America

Once again this year, the Pennsylvania Society of the Sons of the American Revolution is partnering with the Wreaths Across America. Wreaths Across America's mission is to REMEMBER the fallen – HONOR those who serve and TEACH our children the value of freedom. Wreaths Across America was started in 1992 by Morrill Worcester of the Worcester Wreath Company, a family owned business located in Harrington, Maine. Forced with a large overstock of fresh-cut balsam wreaths that year, Worcester decided to donate 5,000 of them to be placed on the graves in Arlington National Cemetery in Virginia. That tradition has continued each year since, until a picture of the wreaths project hit the internet and spread to other National cemeteries. In all, last year, 1,700,000 wreaths were placed at more than 2,500 cemeteries across the country including 25 overseas. There are several cemeteries that take part in Pennsylvania. Compatriot Floyd Turner assists at Indiantown Gap National Cemetery where last year nearly 43,000 wreaths were placed. This year they are hoping to get sponsorships for 45,000 wreaths.

The George Washington Chapter got sponsors for 3,184 of the 16,000 wreaths that were placed at the National Cemetery of the Alleghenies located in Washington County, once again, making it the largest gatherer of wreaths for that cemetery. For the fifth consecutive year, with graves that were already decorated by families, every one of the graves were marked. The George Washington Chapter kicked off its annual campaign with an envelope stuffing at the chapter's annual picnic. This year nearly 400 envelopes were filled to be sent to past sponsors. Wreath sponsorships are \$15.00 each and anyone wishing to sponsor a wreath or who would like more information should contact Floyd Turner (610)406-3933 in the East and Gary Timmons (304)242-8759 in the West. In life they served their country and now is a chance for us to honor them.
