The first portion of this report covers the Reserve. The last paragraph provides information on the Permanent Fund PASSAR.

## Reserve

This report is submitted for the period January 31, 2021 through March 31, 2021. This report is being filed pursuant to Bylaw No. 8, Section 8.05-a. **Quarterly Reports.** The Annual Meeting is being hosted on April 30 & May 1, 2021 by the General Anthony Wayne Chapter.

As of March 31, 2021 the Reserve total was \$159,445.42. Of this amount \$6,558.89 was held in the Wells Fargo brokerage account in cash. In addition, \$1,014.04 was held in the Citizens Bank checking account in cash. The total of cash in both accounts in the amount of \$7,572.93 was available for transfer to the PASSAR General Operating Account, if needed. The remaining funds, the non-cash items, in the Wells Fargo brokerage account are invested in various equities, bonds and mutual funds.

In addition to the above investments, PASSAR maintained, until the end of December, cash in a restricted Citizen's Bank account that was dedicated to the support of the Museum of the American Revolution pursuant to PASSAR's pledge to donate a total of \$50,000 in increments of \$10,000 per year over five years. To date five installments of \$10,000 each have been made on PASSAR's five year pledge. The first \$10,000 was paid by a Citizens Bank counter-check dated September 2, 2016. The second \$10,000 installment was paid by PASSAR's Citizens Bank check dated September 1, 2017. The third \$10,000 installment was paid by PASSAR's Citizen Bank check dated September 12, 2018. The fourth \$10,000 installment was paid by PASSAR's Citizen Bank check dated November 4, 2019. The fifth and last \$10,000 installment was paid by Citizens Bank's Official Check dated December 23, 2020.

The following is a summary of the Reserve maintained in the Wells Fargo Advisors and Citizens Bank Accounts commencing as of January 1, 2018.

**Footnote 2** – By letter from William J. McKim dated August 5, 2019 a check in the amount of \$986.01 was deposited in the Wells Fargo Advisors Reserve Account. This amount was a reimbursement from PASSAR for that which was not spent in support of the Oration Contest of the \$3,000.00 referenced above in **Footnote 1**.

**Footnote 3** – On March 10, 2020 at the request of PASSAR Treasurer Donald E. Mengle, \$408.94 was withdrawn from the PASSAR Reserve Account held by Wells Fargo Advisors with the approval of the Reserve Managers. Wells Fargo Advisors issued a check in the amount of \$408.94 made payable to PASSAR. The amount of the check was to cover 161 Life Memberships. The check was delivered by regular mail on March 15, 2020.

**Footnote 4** – On March 11, 2020 at the request of PASSAR Treasurer Donald E. Mengle, \$3,137.50 was withdrawn from the PASSAR Reserve Account held by Wells Fargo Advisors with the approval of the Reserve Managers. The check in the amount of \$3,137.50 made payable to PASSAR covered the cost of medals.

**Footnote 5** – On April 8, 2020, PASSAR Treasurer Donald E. Mengle informed the Reserve Chairman that \$2,500 will be required from the Reserve to cover the cost of our supporting the Rumbaugh Oration Contest.

Footnote 6 - The fifth and last \$10,000 installment was paid by Citizens Bank's Official Check dated December 23, 2020.

Footnote 7 – On January 29, 2021 Citizens charged a \$10 service charge for a Dormant Account Fee.

Footnote 8 – On February 26, 2021 Citizens charged a service charge of \$5 for a Dormant Account Fee.

## Permanent Fund PASSAR



Three chapters submitted scoresheets to me for the 2021 Americanism Award/President General's Activity Streamer, and therefore they earned a flag streamer. Two chapters – Continental Congress and George Washington – won the medium and large size chapter categories, respectively. There was no submission in the small chapter category. Although it's very disappointing that so few chapters chose to participate – only a third of last year's entries – I attribute the low participation mostly to the pandemic and partially to the fact that chairman's report did not find its way into recent BOM compilations.

The results of the competition are shown in the "Score" column in the table below, with the chapters organized by size groupings. The winning chapter for each group is determined by dividing the number of members in the chapter (as reported by the chapter) into the total score reported on the chapter's scoresheet. As stated above, the winning chapters shown in bold below are Continental Congress (medium), and George Washington (large). Scores had to be entered in at least 12 of the 16 scoresheet categories to compete.

NSSAR has revised the scoresheet for 2021 including reducing the number of tabs from 16 to 12 through consolidations and other modifications. Consequently, in order to compete for an award, a chapter must

have activity in 9 of 12 category tabs for Americanism and 5 of 7 for the PG Streamer. However, I encourage each chapter to complete a scoresheet regardless of the number of categories in which a chapter engages since the scoresheet acts as a guide and record for chapter activities. Chapter size categories for competition are now designated as 1-40, 41-90, 91-150, and 151+.

I urge each chapter to participate in the 2021 Americanism/Activity Streamer program by completing the scoresheet through the link distributed to all chapter contacts in March, found on the NSSAR website through the Americanism Committee, or by requesting a copy from me. It would be helpful to the chapter to enter data throughout the year as activities occur. Lastly, because NSSAR cut 2 weeks off its deadline, please observe a firm deadline of February 15, 2022, or preferably sooner, to submit the 2021 scoresheet to me so that I have time to consolidate the information into PASSAR's scoresheet. I'm hoping many more chapters will choose to document their activities this year.

At the time the 2024 Medals Order Form was prepared, the shipping cost for one medal (with free insurance on items under \$50 value) was \$7.35.

By the time the first order was shipped on April 30, 2020, USPS had raised the shipping cost for Priority Mail Small Flat Rate Boxes (insured for <\$50) to \$8.30. This created a net loss of 95¢ per shipment for an order of one medal — or a **total deficit of \$27.55** for 29 medals. There were also three (3) orders of 2 or more medals filled that I can not easily calculate the loss on because of differing insurance cost. The latest order for one medal shipped on March 5 indicates shipping cost of \$8.45 - an apparent rate increase. This would increase deficit on each single medal shipped to \$1.10.

Action needed: The "committee" should decide if the ads for the medals should be adjusted to reflect the change or if the medal project will absorb the difference.

As the postage for ALL mailed medal orders was printed using my personal USPS Mailing Account, I am claiming reimbursement as follows:

In *American Scripture*, Pauline Maier traces the evolution of the Declaration of Independence from merely a statement that Americans were dissolving the political bands which had connected them to Great Britain, to an expression of national identity, and more, a moral compass to what it means to be an American. But along the way from a political document to a source of inspiration for all Americans, the Declaration has been understood and used in a myriad of ways, and for a number of purposes. *Interpreting Independence* shall explore such questions as ...

- > How have different generations of Americans interpreted the Declaration of Independence to advance the causes and address the concerns of their times?
- > How has the Declaration been used to promote various causes?
- Which components of the Declaration have been central to the rhetoric of the time? ("All men are created equal ... endowed by their Creator with certain unalienable Rights "? "To secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed"? Or other ideals and principles set forth in the Declaration?)
- Under what circumstances has the Declaration been used conspicuously? Under what circumstances has it been ignored?

By no means is this list of questions exhaustive. By no means will this conference address all the questions that may be asked about the Declaration. But the conference shall explore the seminal role of the Declaration as *the* Founding Document of the American Republic.

*Interpreting Independence: The Declaration Through the Generations* shall be dedicated to James Kirby Martin, the Hugh Roy and Lillie Cranz Cullen University Professor of History at the the University of Houston.
