The first portion of this report covers the Reserve. The last paragraph provides information on the Permanent Fund PASSAR.

### Reserve

This report is submitted for the period through June 30, 2022. This report is being filed pursuant to Bylaw No. 8, Section 8.05-a. **Quarterly Reports.**

As of June 30, 2022 the Reserve total was \$154,465.07. Of this amount \$5,608.77 was held in the Wells Fargo brokerage account in cash. In addition, \$1,039.19 was held in the Citizens Bank checking account in cash. The total of cash in both accounts in the amount of \$6,647.96 was available for transfer to the PASSAR General Operating Account, if needed. The remaining funds, the non-cash items, in the Wells Fargo brokerage account are invested in various equities, bonds and mutual funds.

In addition to the above investments, PASSAR maintained cash in a restricted Citizen's Bank account that was dedicated to the support of the Museum of the American Revolution pursuant to PASSAR's pledge to donate a total of \$50,000 in increments of \$10,000 per year over five years. To date five installments of \$10,000 each have been made on PASSAR's five year pledge. The first \$10,000 was paid by a Citizens Bank counter-check dated September 2, 2016. The second \$10,000 installment was paid by PASSAR's Citizens Bank check dated September 1, 2017. The third \$10,000 installment was paid by



PASSAR's Citizens Bank check dated September 12, 2018. The fourth \$10,000 installment was paid by PASSAR's Citizen Bank check dated November 4, 2019. The fifth and last \$10,000 installment was paid by Citizens Bank's Official Check dated December 23, 2020.

These transfers of money were required to comply with the terms of three bequests of the Joseph Ramsey and Elizabeth Ramsey wills. The Permanent Fund PASSAR is managed and reported on by Russell L. Mills, the PASSAR Treasurer & Secretary, independent of the Reserve.

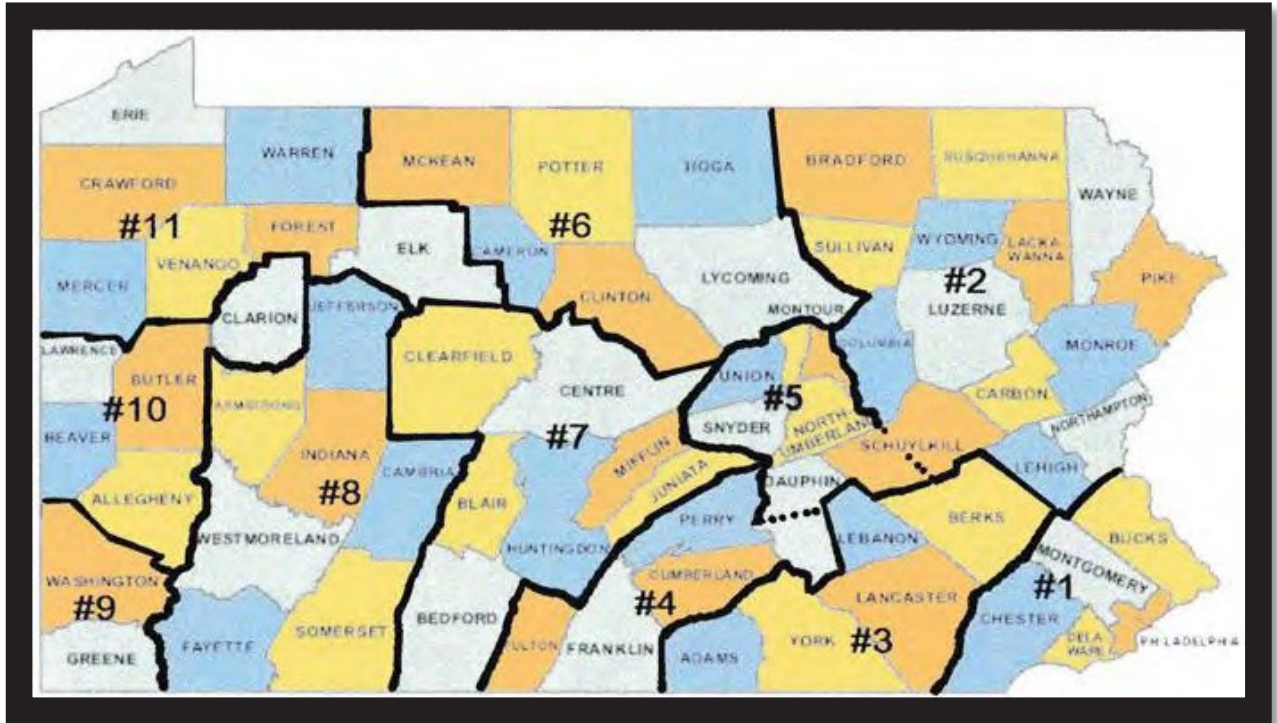

This statute is the only known example of George Washington in a British military uniform. It was placed 100 years ago to mark the mission authorized by the Virginia colonial governor to meet with the French over conflicting claims by both France and Colonial Virginia for this part of current day Pennsylvania.

Both the Erie Chapter and the Ben Franklin Chapter plan to participate in this event.

## **PATRIOT CHEST**

The Patriot Chest is a tool used by many State Societies to bring the Revolutionary War into the classroom. It uses student engagement to make the history come alive rather than the usual rote method of teaching history that mainly includes reciting names and dates.

As the 250 celebration is important to us, we believe it is appropriate that our program be officially recognized by the America250PA Committee. To accomplish that task, we would tailor the program by reducing the emphasis on the Revolutionary War and placing more emphasis on what life was like 250 years ago. To get student engagement, we would use the props from the chest to stimulate their curiosity about those times.

One of the history tools suggested by the America250PA Committee is the 100-question exam asked of new citizens applying for citizenship in the USA. Many of these would not be appropriate for our use and the introduction to the usable questions would be dependent upon the grade level of the students receiving our presentation, e.g., students of boy or girl scout age would understand the Apache or Sioux Indian nations, but 3rd grade student would probably not. (Question 87 on the test asks for the name of one Indian tribe.)

As an example, on integration of the questions into the presentation:

While explaining how to make homemade soap, or the need to wear bonnets because of open cooking fires or long unwashed hair, the students would be shown how difficult life was in the colonies. A discussion of why someone would leave their homeland to come to the Colonies 250 years ago could follow. Our compatriots, dependent upon student grade level, could easily slip into a discussion of freedom of speech, religion, assembly, press or the concept of pursuit of happiness. (Question 6 is the first amendment and question 8 covers the rights found in the Declaration of Independence.)

We are working with local educators to develop a script and the viability of inserting various questions into that script. Once completed, we will present our finding to the executive committee of the Pennsylvania society and, if approved, to the America250- PA commission.

Executive Committee Report**

The Executive Committee held three meetings this quarter.

**May 15, 2022**

The committee held a discussion on the current budget consisting of last year's budget as presented at the May 7, 2022 Annual Meeting, and the need for a revised budget. The Treasurer was instructed to prepare a revised budget for the 2022-2023 year.

The committee discussed the need for new accounting software that would meet the needs of a nonprofit organization. a discussion The Treasurer was instructed to search for software that would fulfil PASSAR's requirements for the use of fund accounting as a nonprofit entity and full accrual accounting.

The committee examined George Clarke's request to increase the prize money for the grade school poster contest from 1<sup>st</sup> place \$200, 2<sup>nd</sup> Place \$150, and 3<sup>rd</sup> Place \$100 to \$300, \$200 and \$100 respectively. The committee recommended this increase be presented to the Board of Management at the August meeting.

The committee authorized the Treasurer to pay all outstanding bills as authorized in the current and prior year budget.

The committee addressed the need for Color Guard Liability Insurance. The Treasurer was authorized to enter into a contract with Lockton Affinity LLC at a cost of \$737.25 for insurance coverage. The contract went into effect on May 22, 2022, just in time for Memorial Day festivities.

**June 13, 2022**

The committee was briefed by the Treasurer on the cost of accounting software. PASSAR would need to spend well over \$10,000 to buy the necessary software for a nonprofit organization of our complexity. As a result, PASSAR staff would develop the accounting software in-house. The committee was briefed by the Treasurer on PASSAR's prior year financial position. Both the actual revenues and the actual expenses far exceeded the budgeted amounts. At the time of the meeting, the accounts were not fully analyzed so the final gain or loss for the year had not been determined.

The committee discussed the dues collection process and that it did not work well last year for various reasons: the communication of dues notices, the vagueness of the notices, the confusion over how to pay, and the \$3,285 cost to allow members to pay with credit cards. The committee would continue the discussion on the dues collection process at its next meeting.

**July 19, 2022**

The committee examined the completed budget versus actual revenue and expense budget for the year May 1, 2021 to April 30, 2022. From that information, the committee examined the proposed budget revision for the current year period from May 1, 2022 to April 30, 2023. The committee recommended the revised budget be presented to the Board of Management at the August meeting.

The Treasurer reported that he had cancelled the arrangements with Truist Bank to accept credit card payments of dues for the upcoming dues collection season. The committee decided to allow chapters two options for dues payment this fall.

- First, Chapters could continue to use PASSAR as its dues collection agency. PASSAR would collect all National, State and Chapter dues. PASSAR would remit the Chapter dues to the Chapters after the end of the dues collection period.
- Second, Chapters could collect their own dues. Chapters would retain their own dues. Chapters would remit State and National dues to PASSAR several times during the dues collection period with all State and National dues submitted to PASSAR by December 1, 2022. That would allow PASSAR time to reconcile dues records and pay National dues by December 31, 2022.

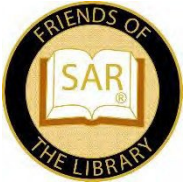

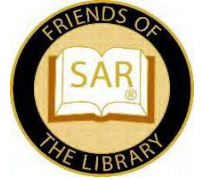

## RESOLUTION

At the Fall 2020 BOM in Pittsburgh, a resolution was passed requiring all PASSAR Officers to take the online NSSAR Youth Protection Training. The following Resolution was drafted by FP Wayne Strasbaugh to solidify this requirement by inserting it into the Bylaws. The following Bylaw Resolution was introduced at the Spring 2022 Board of Management Meeting for consideration, to be followed by a Board of Management vote at the Summer 2022 Board of Management Meeting:

RESOLVED, that the caption to Section 6.02 of the Bylaws be amended to read as follows:

**Section 6.02. Duties and Reports Required of Officers; Changes in NSSAR Roster of Members; Completion of Youth Protection Program**

RESOLVED, that the following two paragraphs be inserted at the end of Section 6.02 of the Bylaws:

Each Officer shall deliver to the Secretary a currently effective certificate of his completion of the NSSAR Youth Protection Training course (a “YPT Certificate”) within three months after his election and, if a YPT Certificate expires before the conclusion of his term of office, no later than the expiration date of such YPT Certificate. An Officer elected prior to the Annual Meeting of the Society in 2021 whose term ends after the date of such Annual Meeting shall deliver a YPT Certificate within three months after the date of the Annual Meeting. Any Officer that fails to deliver a YPT Certificate to the Secretary within the time period specified for such delivery shall be deemed to have resigned and his position shall be filled in accordance with the provisions of Bylaw Section 6.17 (Filling Officer Vacancies).

The Board may by resolution impose similar requirements for the delivery of YPT Certificates as prerequisites for service as chairmen or members of Committees that the Board determines are likely to bring compatriots into contact with persons 18 years of age or younger.

RESOLVED, that the Society recommends that each of its Chapters adopt amendments to its bylaws requiring the completion of the NSSAR Youth Protection Training course as a prerequisite for service on Chapter committees that are likely to bring compatriots into contact with persons 18 years of age or younger.

### Tiadaghton Elm - Fair Play Men Medal

The Pennsylvania Society, SAR proudly presents a Pennsylvania Society Medal honoring brave patriots known as the Fair Play Men and their fight for freedom declared under an elm tree. These struggling settlers, battling a vast wilderness 200 miles from Philadelphia, were forced to fend off British and Indian attacks. On July 4<sup>th</sup>, 1776, unaware of the actions of the Continental Congress, they signed their own Declaration of Independence. Compatriots and historians see this concurrent event as a sign of the hand of God on the Revolution. Many of the Fair Play Men would die fighting to create a new nation.

This medal may be purchased and worn by any active member of the SAR, not limited to members of PASSAR or to descendants of the Fair Play Men who signed their Declaration under the Tiadaghton Elm. Medal sets of large and mini medals enclosed in official SAR medal cases will be struck. The medals are offered at \$40.00 per set (postage included).

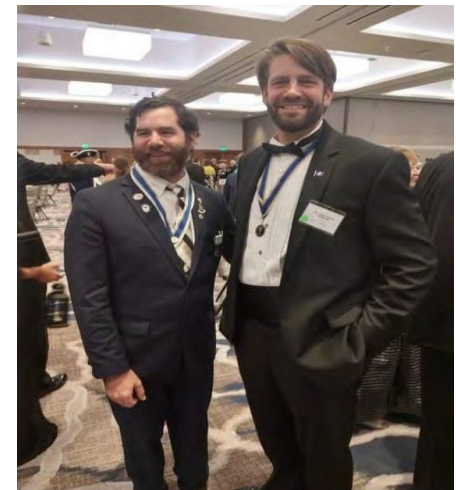
