### Suggested Memorial Flag Streamer Ceremony for Departed SAR Compatriots

#### 1. Memorial Flag Streamer:

For a standard 3 'x 5' foot SAR Flag, an appropriate size black Memorial Flag Streamer would be 3-inches wide and 5-feet long attached atop a flag pole or a flag pole mounting ring. It is used on the indoor/parade SAR Flag which can not be lowered to half-staff.

#### 2. Memorial Flag Streamer Ceremony:

This ceremony is modified from the American Legion. It can be performed at the start of a business meeting, luncheon, or dinner to honor any departed compatriot since the last the time the organization meet. The streamer typically hangs the length of the event.

**President:** "Compatriots rise and face the chapter's colors"

**President:** "Will the Color Guard Commander bring the SAR Flag forward and lower the flag. The color guard will attach the Memorial Flag Streamer to our SAR Flag to honor our departed Compatriot \_\_\_\_\_."

**President:** "By this act we, as compatriots of the \_\_\_\_\_ Chapter/ State/ District/National Society, proclaim solemn tribute to our departed compatriot. Color guard please post the SAR Flag. Please be seated"

(At this point the president can present a biography of the departed compatriot that emphasizes his service to the nation, community, church/synagogue and the SAR. If the compatriot's family is present, it would be appropriate to present his family with the **SAR Memorial Certificate.**)

**Chaplain:** "Almighty God, who has dominion over life and death, grant to us the grace to remember with love and reverence our valiant and honored compatriot. Grant peace and eternal rest to those who have gone before us and make us ready for that final hour. Strengthen and console those in sorrow and bestow upon us your everlasting blessing. Amen"

(The president raps the gavel once and announces that the meeting, luncheon or dinner will continue.

#### 3. Another SAR Memorial Ceremony for a Departed SAR Compatriot:

The Memorial Flag Streamer Ceremony can be combined but does not replace the "Suggested Memorial Service for Departed SAR Compatriots" found in the **SAR Handbook Volume IV: Insignia, Protocol, Ceremonies & Rituals.**

I prepared a Balance Sheet for the period ending on January 27, 2023, and a Statement of Revenues and Expenses from May 1, 2022, through January 27, 2023, for your use. Also, for your use, I have included two supplemental reports: a report comparing the actual revenues and expenses with the current year budget, and a report on the 2024 Congress Activities through January 27, 2023. I have also included for you use a report carried forward from prior years that lists all the office and meeting equipment in use by the PASSAR officers or in the storage room.

As Treasurer, I want to bring to your attention several activities and events that impact on the financial health of our organization. First, PASSAR's annual dues collection process from September to December is complete.

Second, I have now added all Wells Fargo financial information from May 1, 2022 through December 31, 2022 in the financial statements.

Third, the stock market has not been favorable in 2022. PASSAR's market values of its investments in both PNC and Wells Fargo are down from prior year. I am still holding \$69,829.48 of Unrestricted and \$22,279.48 of Permanently Restricted cash awaiting a positive change in the market.

Fourth, I have completed my study of PASSAR member life expectancies. The life expectancy of a PASSAR member using death dates from four prior years, is approximately 84 years. The life expectancy of a PASSAR member who was a life member at the time of death is approximately 93 years. New PASSAR Life Expectancy tables are included later in the meeting book under new business.

Fifth, PASSAR was granted a six-month extension to March 15, 2023, to file its form 990-N for the 2022 operating year. am still on target to meet the March 15, 2023, due date.



### **NEW BUSINESS**

### 1. Proposed changes to BYLAW NO. 9 FEES AND DUES

Section 9.01. – Admission Fees for Regular Members, additional Family Members, Junior Members, and Memorial Memberships

The National and State dues and fees shall be consistent with the amounts approved by the National Society Sons of the American Revolution at its National Congress and the Pennsylvania Society Sons of the American Revolution Board of Management.

A Regular Member is defined as a male age 18 or older who pays annual dues. Only regular members may vote and hold office in the SAR and receive the SAR Magazine for free. The "first year's dues for the National Society" and "the first year's dues for the Pennsylvania Society" provided above cover dues for the then current year, except that in the case of an application accepted by the Society on or after September 1 of the current year shall cover the applicant's membership in the National Society and the State Society for the next succeeding year.

Family members may all apply for membership at the same time, and will be allowed to claim reduced fees. The family members must all apply as members under the Pennsylvania Society. Applicants from separate State Societies do not meet the definition of Family Applications.

A Junior member is defined as a male under the age of eighteen (18) who files the appropriate lineage and is required to pay annual dues. Junior members do not have the right to vote or receive the SAR Magazine until the age of 18.

An SAR Member may apply for a Memorial Membership for a deceased, close, male relative of that SAR member in good standing, whose application is based on (most of) the same linage as that SAR member. There are no dues and a portion of the application fee goes to the Society's Permanent Fund. Note: To file a Memorial application, the SAR member will complete a stand membership application form proposing his deceased male relative, who must be within two generations of the SAR member, i.e. son, grandson, nephew, grand-nephew, cousin, brother, uncle, father, great uncle, or grandfather.

A separate check payable to the Chapter would pay the Chapter's fees and dues if any.

The remainder of the provisions under Section 9.01 are repealed on February 5, 2023, by order of the PASAR Board of Management.

#### 9.01-a. Fees for Supplemental Applications

The National and State fees for Supplemental Applications shall be consistent with the amounts approved by the National Society Sons of the American Revolution at its National Congress and the Pennsylvania Society Sons of the American Revolution Board of Management.

A separate check payable to the Chapter would pay the Chapter's supplemental fee if any.

### 9.01-b. Fees for Family Applications

The provisions are repealed on February 5, 2023 by order of the PASAR Board of Management.

### 9.01-c. Fees for Supplemental Family Applications

The provisions are repealed on February 5, 2023 by order of the PASAR Board of Management.

#### 9.01-d. Fees for Relatives Between the Ages of 18 and 25

The provisions are repealed on February 5, 2023 by order of the PASAR Board of Management.

#### 9.01-e. Fees for Junior Members

The provisions are repealed on February 5, 2023 by order of the PASAR Board of Management.

### 9.01-g. Fees for Memorial Memberships

The provisions are repealed on February 5, 2023 by order of the PASAR Board of Management.

### Section 9.02. Annual Dues, Payable by December 31 of Each Year

#### 9.02-a. Annual Dues

The National and State dues shall be consistent with the amounts approved by the National Society Sons of the American Revolution at its National Congress and the Pennsylvania Society Sons of the American Revolution Board of Management.

#### 9.02-d. Collection of Dues

All National and State dues must be forwarded to the State Treasurer or his Assistant Treasurer on or before December 31st.

If the State Treasurer collects Chapter dues, all Chapter dues must be forwarded to the State Treasurer or his Assistant Treasurer on or before December 31st. The State Treasurer will submit all Chapter dues to each Chapter Treasurer upon completion of the member reconciliation process with National.

#### 9.02-e. Regular Life Members

A Compatriot in good standing who shall make a single payment comprised of the elements specified in the following schedule shall become a Life Member and shall thereafter be exempt from payment of regular annual dues:

- 1. If the member elects to become a National Life Member, the amount specified by the National Society for the Compatriot's current age.
- 2. If the member elects to become a State Life Member, the amount specified by the Pennsylvania Society for the Compatriot's current age.
- 3. If the member elects to become a Chapter Life Member, the amount specified by the Compatriot's Chapter for the Compatriot's current age.

### 9.02-g. Transfer of Membership

Upon transfer of membership from one Chapter to another, or from a Chapter to membership-at-large, and vice versa, the dues for the year in which the transfer is made shall be paid before the transfer is approved.

Transfers from one Society to another shall be in accordance with the National Society rules and regulations.

### 9.03-a. Payment by Credit Card

The provisions are repealed on February 5, 2023 by order of the PASAR Board of Management.

### 9.03-c. Credit Card Information

The provisions are repealed on February 5, 2023 by order of the PASAR Board of Management.

### Tiadaghton Elm - Fair Play Men Medal

The Pennsylvania Society, SAR proudly presents a Pennsylvania Society Medal honoring brave patriots known as the Fair Play Men and their fight for freedom declared under an elm tree. These struggling settlers, battling a vast wilderness 200 miles from Philadelphia, were forced to fend off British and Indian attacks. On July 4th, 1776, unaware of the actions of the Continental Congress, they signed their own Declaration of Independence. Compatriots and historians see this concurrent event as a sign of the hand of God on the Revolution. Many of the Fair Play Men would die fighting to create a new nation.

This medal may be purchased and worn by any active member of the SAR, not limited to members of PASSAR or to descendants of the Fair Play Men who signed their Declaration under the Tiadaghton Elm. Medal sets of large and mini medals enclosed in official SAR medal cases will be struck. The medals are offered at \$40.00 per set (postage included).

- Members need not, and are not expected to attend Congress or Leadership meetings.






